Can I return a battery?

Whether you can return the battery will depend on where you bought it and whether you've installed it. Some stores will accept new or used batteries for return or exchange; however, most will only offer refunds if the battery is new and uninstalled.

Can you return a battery if it's uninstalled?

Some stores will accept new or used batteries for return or exchange; however, most will only offer refunds if the battery is new and uninstalled. If your battery isn't eligible for a return, the store may offer a replacement or you may be able to get one through the battery's warranty.

What if my battery is ineligible for return?

If your battery is ineligible for return, you may be able to get a refund or replacement through the store's warranty program. The following warranties are available at the stores listed above; the warranty period varies depending on the battery brand and model. You will need proof of purchase to make a warranty claim.

Can a battery be returned if the package is damaged?

No, batteries cannot be returned if the package is damaged or opened. Best practices for preparing a return. Customer service contact information for assistance. 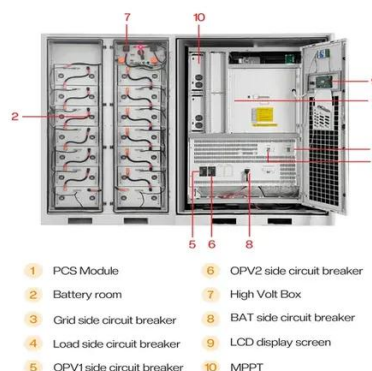

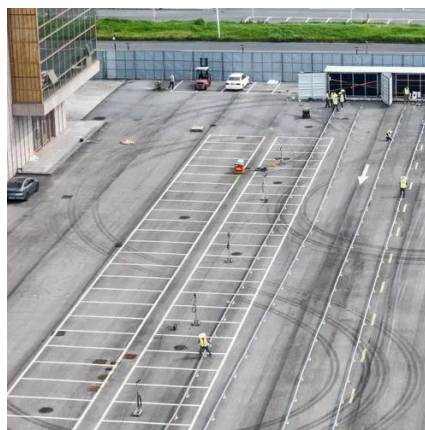
